With respect to the captioned subject, we hereby inform you that there is a breach of covenants as below.

- a) The Company was required to maintain PAR 30 (Own Book) and Write off ratio <10%, and ROA was required to maintain at >0%, However the Provisional ratio stands at 12.91% and ROA Stands at <0% in January- 2026 with respect to ISIN INE366T07162.
- b) The Company was required to maintain PAR 30 (Own Book) and Write off ratio <8%, and ROA was required to maintain at >0%, However the Provisional ratio stands at 13.22% and ROA Stands at <0% in January- 2026 with respect to ISIN INE366T07154.

We are in the process of seeking a waiver from the Debenture Trustee and will inform BSE upon receiving the waiver.
